Key Points

- 1465 potential victims were submitted to the National Referral Mechanism during the period October to December 2017; an 11% increase from the previous quarter July to September 2017.
- Reporting showed potential victims of trafficking originating from 75 different countries this period.
- Albania, the UK and Vietnam remain the most commonly reported nationalities from these, with the United Kingdom being the most referred this quarter.
- The most recorded exploitation type for potential victims exploited as an adult was labour exploitation.
- The most prominent exploitation type recorded for potential victims first exploited as a minor was labour exploitation, which includes criminal exploitation such as cannabis cultivation.
- One case of organ harvesting has been recorded this quarter, although this received a negative reasonable grounds outcome.
- Twelve potential victims were referred for crime recording purposes to Northern Ireland, with 58 to Scotland and 44 to Wales. The remaining 1351 were referred to police forces in England.

National Referral Mechanism Statistics – 2017 Quarter 4

This report presents a summary of the number of potential victims of modern slavery and human trafficking referred in to the National Referral Mechanism (NRM) during the period 1st October to 31st December 2017.

The figures used are from the NRM data with a cut-off date of 10/01/2018. Some of the cases remain open with the Competent Authorities and decisions on their trafficking status are yet to be made. The NRM is a 'living' process and data should be considered provisional until all cases are concluded. Some values may differ from previous or future reports as supplementary information is revealed throughout the duration of a case and their records are adjusted accordingly.

This report does not provide any analysis of the picture of modern slavery in the UK.

The report provides figures relating to the number of potential victims that have been referred in to the NRM process during the reporting period October to December 2017, with no decision data for the case.

Changes Introduced to NRM Data Management

Previous iterations of this report were produced on the basis of the police force and country location of the first responder, irrespective of the claimed location of exploitation or residence of the potential victim at the time of referral. This led to invalid hotspot analysis of the data being applied to police force areas and the devolved regions of the UK.

Following the July 2016 clarification and subsequent update in July 2017 within the Home Office Counting Rules¹ (HOCR) whereby:

“all referrals made by the police into the NRM and all those that the police receive from the NRM with a positive reasonable grounds decision applied must be subject of a recorded crime of MS (modern slavery)”

A subsequent NCA review established that the previous statistical attribution of referrals to a particular country within the UK on the basis of the location of the first responder was misleading.

In support of HOCR requirements, NRM referrals are now screened against the below criteria in order to identify the responsible geographical police force. Once identified, the referral is transmitted within one working day to the relevant Force Intelligence Bureau (FIB), or stipulated point of receipt within force for action. The reasonable grounds decision, once made, is subsequently notified to the force by the competent authority.

Criteria applied to identify relevant force

The force has acted as first responder, or the referral indicates that the force is already involved in the recording/investigation of the potential modern slavery human trafficking (MSHT) offences;

or

The potential victim has been exploited within the force area;

or

The potential victim has been exploited abroad, or at an unknown location and the victim's address at time of referral is within the force area;

or

The potential victim has been exploited abroad or at an unknown location and they have presented to another first responder within the force area.

The Annexes to this report and table overleaf have been compiled on the basis of where the police force that received the NRM referral is located, e.g. Wales will be comprised only of NRM referrals originating from, or sent to Dyfed-Powys Police, Gwent Police, North Wales Police or South Wales Police.

NRM Statistics Quarter 4, October – December 2017

In this quarter, the UK National Referral Mechanism (NRM) received 1465 referrals of potential victims (PV); this represents an 11% increase on the previous quarter. The PVs were reported to be of 75 differing nationalities².

The 1465 referrals were comprised of 628 females (>42%), 836 males (57%) and one transgender case (<1%). Referrals for 806 (55%) for adult exploitation categories and 659 (45%) referred for exploitation as a minor were received.

Annex A - ENGLAND – 2017 Quarter 4

In Quarter 4 2017, the UK National Referral Mechanism (NRM) received 1351 referrals of potential victims (PV) where the referral was subsequently sent to a police force for crime recording considerations in England; this represents >92% of all UK referrals to the NRM, unchanged on the previous quarter.

The 1351 referrals were comprised of 581 females (43%), 769 males (<57%) and one transgender female (<1%). There were 728 (54%) individuals referred for adult exploitation categories and 623 (46%) referred for exploitation whilst a minor.
