Key Points

- 1631 potential victims were submitted to the National Referral Mechanism during the period January to March 2018; an 11% increase from the previous quarter October to December 2017.
- Reporting showed potential victims of trafficking originating from 87 different countries this period.
- Nationals from Albania, the UK and Vietnam remain the most commonly reported, with the United Kingdom being the most referred for the second consecutive quarter.
- The most recorded exploitation type for potential victims exploited as an adult was labour exploitation.
- The most prominent exploitation type recorded for potential victims first exploited as a minor was labour exploitation, which includes criminal exploitation such as cannabis cultivation and County Lines drugs supply.
- One case has been referred this quarter where the potential victim claimed their organs were to be harvested. Whilst no harvesting occurred, the case is under investigation to inform the conclusive grounds decision.
- Over one quarter of referrals received this quarter had no claimed exploitation within the United Kingdom.
- Seven potential victims were referred for crime recording purposes to Northern Ireland, with 53 to both Scotland and Wales. The remaining 1518 were referred to police forces in England.
- An Excel file, *Tables_for_NRM_Q1_2018_INTERNET* containing all tables within the report is separately available to download and use for analytical purposes.

National Referral Mechanism Statistics – 2018 Quarter 1

This report presents a summary of the number of potential victims of modern slavery and human trafficking referred in to the National Referral Mechanism (NRM) during the period 1st January to 31st March 2018.

The figures used are from the NRM data with a cut-off date of 08/04/2018. Some of the cases remain open with the Competent Authorities and decisions on their trafficking status are yet to be made. The NRM is a 'living' process and data should be considered provisional until all cases are concluded. Some values may differ from previous or future reports as supplementary information is revealed throughout the duration of a case and their records are adjusted accordingly.

This quarter sees the introduction of a supporting Microsoft Excel file, *Tables_for_NRM_Q1_2018_INTERNET*, which is available in Excel 97-2003 format to enable users to more readily interact with the NRM data without the requirement for the latest software. This report does not provide any analysis of the picture of modern slavery in the UK.

The report provides figures relating to the number of potential victims that have been referred in to the NRM process during the reporting period January to March 2018, with no decision data for the case.

Changes Introduced to NRM Data Management

Previous iterations of this report were produced on the basis of the police force and country location of the first responder, irrespective of the claimed location of exploitation or residence of the potential victim at the time of referral. This led to invalid hotspot analysis of the data being applied to police force areas and the devolved regions of the UK.

Following the July 2016 clarification and subsequent update in July 2017 within the Home Office Counting Rules¹ (HOCR) whereby:

"all referrals made by the police into the NRM and all those that the police receive from the NRM with a positive reasonable grounds decision applied must be subject of a recorded crime of MS (modern slavery)"

A subsequent NCA review established that the previous statistical attribution of referrals to a particular country within the UK on the basis of the location of the first responder was misleading.

In support of HOCR requirements, NRM referrals are now screened against the below criteria in order to identify the responsible geographical police force. Once identified, the referral is transmitted within one working day to the relevant Force Intelligence Bureau (FIB), or stipulated point of receipt within force for action. The reasonable grounds decision, once made, is subsequently notified to the force by the competent authority.

Criteria applied to identify relevant force

The force has acted as first responder, or the referral indicates that the force is already involved in the recording/investigation of the potential modern slavery human trafficking (MSHT) offences;

or

The potential victim has been exploited within the force area;

or

The potential victim has been exploited abroad, or at an unknown location and the victim's address at time of referral is within the force area;

or

The potential victim has been exploited abroad or at an unknown location and they have presented to another first responder within the force area.

The Annexes to this report and table overleaf have been compiled on the basis of where the police force that received the NRM referral for crime recording is located, e.g. Wales will be comprised only of NRM referrals originating from, or sent to Dyfed-Powys Police, Gwent Police, North Wales Police or South Wales Police.

NRM Statistics Quarter 1, January – March 2018

In this quarter, the UK National Referral Mechanism (NRM) received 1631 referrals of potential victims (PV); this represents an 11% increase on the previous quarter. The PVs were reported to be of 87 differing nationalities².

The 1631 referrals were comprised of 678 females (>42%), 952 males (58%) and one transgender case (<1%). Referrals for 920 (56%) for adult exploitation categories and 711 (44%) referred for exploitation as a minor were received.

Annex A - ENGLAND – 2018 Quarter 1

In Quarter 1 2018, the UK National Referral Mechanism (NRM) received 1518 referrals of potential victims (PV) where the referral was subsequently sent to a police force for crime recording considerations in England; this represents 93% of all UK referrals to the NRM.

The 1518 referrals were comprised of 629 females (41%), 888 males (58%) and one transgender female (<1%). There were 836 (55%) individuals referred for adult exploitation categories and 682 (45%) referred for exploitation whilst a minor.
