Key Points

- 2156 potential victims were submitted to the National Referral Mechanism during the period January to March 2019; a 10% increase from the previous quarter October to December 2018.
- Reporting showed potential victims of trafficking originating from 78 different countries this period.
- Nationals from Albania, the United Kingdom and Vietnam remain the most commonly reported, with the UK being the most referred for the sixth consecutive quarter.
- The most recorded exploitation type for potential victims exploited as an adult was labour exploitation.
- The most prominent exploitation type recorded for potential victims first exploited as a minor was labour exploitation, which includes criminal exploitation such as cannabis cultivation and County Lines drugs supply.
- Nearly 30% (646) of referrals received this quarter had no claimed exploitation within the United Kingdom, with a further seven percent (155) where no location was identified.
- The Police Service of Northern Ireland received 13 referrals for crime recording purposes, with 82 referred to Police Scotland and 60 referred to Welsh forces. The remaining 2001 were referred to police forces in England.

National Referral Mechanism Statistics – 2019 Quarter 1

This report presents a summary of the number of potential victims of modern slavery and human trafficking referred in to the National Referral Mechanism (NRM) during the period 1st January to 31st March 2019 and is the final quarterly report in this format, prior to the transfer of the NRM to the new Home Office Single Competent Authority in April 2019 as part of a wide-reaching NRM Reform Programme.

The figures used are from the NRM data with a cut-off date of 03/04/2019. Many of the cases remain open with the Competent Authorities and decisions on their trafficking status are yet to be made. The NRM is a 'living' process and data should be considered provisional until all cases are concluded. Some values may differ from previous or future reports as supplementary information is revealed throughout the duration of a case and their records are adjusted accordingly.

Percentages are rounded to the nearest whole percentage point.

This report does not provide any analysis of the picture of modern slavery in the UK.

The report provides figures relating to the number of potential victims that have been referred into the NRM process during the reporting period January to March 2019 with no decision data for the case.

Changes Introduced to NRM Data Management

Previous iterations of this report were produced on the basis of the police force and country location of the first responder, irrespective of the claimed location of exploitation or residence of the potential victim at the time of referral. This led to invalid hotspot analysis of the data being applied to police force areas and the devolved regions of the UK.

Following the July 2016 clarification and subsequent update in July 2017 within the Home Office Counting Rules¹ (HOCR) whereby:

"all referrals made by the police into the NRM and all those that the police receive from the NRM with a positive reasonable grounds decision applied must be subject of a recorded crime of MS (modern slavery)"

A subsequent NCA review established that the previous statistical attribution of referrals to a particular country within the UK on the basis of the location of the first responder was misleading.

In support of HOCR requirements, NRM referrals are now screened against the below criteria in order to identify the responsible geographical police force. Once identified, the referral is transmitted within one working day to the relevant Force Intelligence Bureau, or stipulated point of receipt within force for action. The reasonable grounds decision, once made, is subsequently notified to the force by the competent authority.

Criteria applied to identify relevant force

The force has acted as first responder, or the referral indicates that the force is already involved in the recording/investigation of the potential modern slavery human trafficking (MSHT) offences;

or

The potential victim has been exploited within the force area;

or

The potential victim has been exploited abroad, or at an unknown location and the victim's address at time of referral is within the force area;

or

The potential victim has been exploited abroad or at an unknown location and they have presented to another first responder within the force area.

The Annexes to this report and table overleaf have been compiled on the basis of where the police force that received the NRM referral for crime recording is located, e.g. Wales will be comprised only of NRM referrals originating from, or sent to Dyfed-Powys Police, Gwent Police, North Wales Police or South Wales Police.

The Annexes do not reflect where the initial force has subsequently transferred the crime recording responsibility to another force.

NRM Statistics Quarter 1, January – March 2019

In this quarter, the UK National Referral Mechanism (NRM) received 2156 referrals of potential victims (PV); this represents a 10% (195) increase on the previous quarter. The PVs were reported to be of 78 differing nationalities.

The 2156 referrals were comprised of 773 females (<36%), 1382 males (64%) and one transgender individual (<1%). There were 1212 (56%) referrals for adult exploitation categories and 944 (44%) in the minor exploitation types.

During this reporting period, the new Single Competent Authority (SCA) operated as a shadow function alongside the existing competent authorities, receiving and processing NRM referrals in preparedness for the transfer of responsibilities to the SCA in April 2019.

Annex A - ENGLAND – 2019 Quarter 1

In Quarter 1 2019, the UK National Referral Mechanism (NRM) received 2001 referrals of potential victims (PV) where the referral was subsequently sent to a police force for crime recording considerations in England; this represents <93% of all UK referrals to the NRM.

The 2001 referrals were comprised of 715 females (<36%), 1285 males (>64%) and one transgender individual (>1%). There were 1124 (56%) individuals referred for adult exploitation categories and 877 (44%) referred for exploitation whilst a minor.
