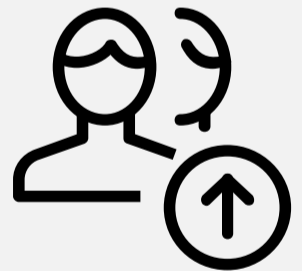


June SAR Portal User Growth

The Programme would like to **extend an open invite** to any reporting organisation who would like to **register to the new SAR Portal to submit SARs ahead of the Public Launch**.



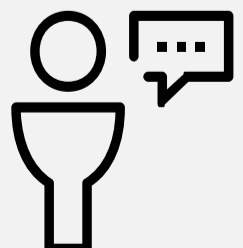
To register your organisation:

- Download an **'Expression of Interest Form'** from the NCA website.
- Complete all required fields
- Return the form to **SARsITTransformation@nca.gov.uk**

As a reminder, once your organisation has registered to the new SAR Portal, your organisation should only use the new Portal to submit SARs.

Reporter Onboarding Continues

The **first five Bulk Reporting Organisations** are now live, with **further reporters expected to go-live in July**.

The **number of SARs submitted via the Bulk API continues to grow** month-on-month as we **continue to onboard high-volume SAR reporters**.

What Do We Need From Bulk Reporters?

Pre-Go-Live

Continue to Progress Readiness Activities: Please ensure that your **integration testing is completed four weeks prior to smoke testing**, which is the **final readiness activity before your Go-Live**. Please also ensure you keep the Programme informed if your go-live date changes.



Post-Go-Live

Provide Feedback: Please ensure to complete your **post-Go-Live feedback survey**, which you will receive **two weeks following your initial submission**.
